No.F.14-31-2011 [CPPI-II] dated 04.09.2018 regarding Aadhaar number – **not to publish or display the Aadhaar number of the students publicly** and also noted UGC earlier directions dated 21.03.2017 as under and also approved by Academic Council on 21.04.2017:-

The Members of the Board of Management **noted** that the DCI revised MDS Regulations dated 01.09.2017 vide their Gazette Notification No.DE-87-2017

and further also Amended on 14.03.2018 vide their Gazette Notification No.DE-87(1)-2018. The members of the BOM also noted the following:-
