- 3(2) TO CONSIDER NMC LETTER NO. NMC/US(NMC)/2022/74/008324 DATED 01.02.2022 FOR COMMENCEMENT OF ACADEMIC YEAR 2021-22 FOR MBBS COURSE W.E.F 14.02.2022 AND TENTATIVE ACADEMIC CURRICULUM AND UNIVERSITY EXAMINATION OF MBBS 2021-22 [FEB-22] BATCH

The members of the **Board of Management** considered the **Minutes/ recommendations** of **Academic Council** and **noted** the following:

- 1. That NMC has directed vide their letter No. NMC/US(NMC)/2022/74/008324 dated 01.02.2022 that due to delay in starting of MBBS admissions on account of Covid Pandemic in the year 2021, it has been decided that the Academic Session for the MBBS Course for the year 2021-22 to be commenced from 14.02.2022. The NMC has also provided the Tentative Academic Curriculum and University Examination Schedule for the batch 2021-22 started in February 2022. Accordingly, the Santosh Medical College & Hospital has commenced the Session of MBBS for the year 2021-22 [Feb-22] batch from 14.02.2022.
- 2. That the NMC has further directed to subsume the foundation course of dedicated one month within first professional of eleven months instead of thirteen months. Foundation Course will be covered after usual teaching hours on weekends/ holidays. Vacations have also been curtailed during first, second, third professionals by one month. The final professional Examinations for the 2021-22 [Feb-22] batch will place in June 2026.

The Members of the **Board of Management** after considering the recommendations of the Academic Council, **decided / approved** as under:

"The directions of the NMC for starting the Session of MBBS for the year 2021-22 [Feb-22] batch from 14.02.2022 was **complied** vide office letter No SU/R/2022/270 dated 08.02.2022. The members of the **Board of Management** considered the **Minutes/recommendations** of **Academic Council Noted** that as per the directions of NMC vide their letter No. NMC/US(NMC)/2022/74/008324 dated 01.02.2022, the Academic Session for the MBBS Course for the year 2021 commenced from 14.02.2022

Accordingly, the Teaching Schedule including the **Foundation Course and AETCOM** for the MBBS Phase-I 2021-22 [Feb-22] batch which has been uploaded on the University website and the same is being compiled and will be printed after obtaining alterations / additions in the teaching schedule from the concerned Head of the Department and through the Dean, Santosh Medical College & Hospital. The same will be provided to the students and the concerned department's faculty for the new session started from February 2022.

# 3(4) TO COMPILE TEACHING SCHEDULE OF BDS 1<sup>ST</sup> YEAR 2021-22 [FEB-22] BATCH

The members of the **Board of Management** after considering the recommendations of the Academic Council, **decided / approved** and **noted** that as per the directions of Ministry of Health & Family Welfare orders No. F.No. U-11011/08/2021-MEC dated 19.01.2022 and DCI vide their letter No. DE-NEET(UG)Admission-2021/407 dated 20.01.2022 for starting **new session of BDS Course** for the Academic Year 2021-22 from 10.02.2022 onwards.

Accordingly, the teaching schedule for the BDS 1<sup>st</sup> Year 2021-22 [Feb-22] Batch and the same is being compiled and will be printed after obtaining alterations / additions in the teaching schedule from the concerned Head of the Department and through the Dean, Santosh Dental College & Hospital. The same will be provided to the students and the concerned department's faculty for the new session started from February 2022.

The members of the **Board of Management** considered the **Minutes/ recommendations** of **Academic Council** and **noted** the following:

- 1) That the DCI vide their letter no. DE-NEET-Admission-MDS-2021/3571 dated 14.01.2022 directed to complete Compulsory Paid Rotatory Internship by **31.03.2022** and **it remains 31**<sup>st</sup> **of March every year**.
- 2) That the Ministry of Health & Family Welfare vide their letter No. Z-28011/68/2021-MEC/DE dated 17.02.2022 has extended the date of completion of Compulsory Paid Rotatory Internship up to 31.07.2022 instead of 31.03.2022 due to representations and Postponement of MDS NEET Examination from 06.03.2022 to 02.05.2022 for the batch 2016-17.
- 3) That the DCI vide their letter dated 14.01.2022 also indicated that the BDS Internship of **every batch** to be completed by **31**<sup>st</sup> **March of every year** for becoming eligible to appear for NEET MDS Examination.
- **4)** That the BDS Final Year (2016 Batch) Examination was conducted in October / November 2020 and Internship was started in January 2021. The 2016-17 batch completed their Internship in **January 2022.**

The Members of the **Board of Management** after considering the recommendations of the Academic Council **decided / approved** to implement the directions of the DCI letter dated 14.01.2022 and MoHFW letter dated 17.02.2022 as per above paras (1), (2), (3) and (4) for completion of BDS Internship of **every** 

**batch** by 31<sup>st</sup> March of every year for becoming eligible to appear for NEET MDS Examination.

The Members of the **Board of Management** also **approved** to extend the date of completion of Compulsory Paid Rotatory Internship up to **31.07.2022** for the **batch 2016-17** due to Postponement of MDS NEET Examination from 06.03.2022 to 02.05.2022 as per directions of the Ministry of Health & Family Welfare vide their letter No. Z-28011/68/2021-MEC/DE dated 17.02.2022.

3(6) TO CONSIDER FOR IMPLEMENTATION OF (i) COURSE IN ETHICS AND (ii) COURSE IN BASIC CARDIAC LIFE SUPPORT SKILLS (BCLS) TO ALL PG MEDICAL STUDENTS FROM 2021-22 BATCH ONWARDS, SANTOSH MEDICAL COLLEGE & HOSPITAL

The members of the **Board of Management** after considering the recommendations of the Academic Council, **decided / approved** as under:

"To implement the (i) COURSE IN ETHICS AND (ii) COURSE IN BASIC CARDIAC LIFE SUPPORT SKILLS (BCLS) TO ALL PG MEDICAL STUDENTS FROM 2021-22 BATCH ONWARDS, SANTOSH MEDICAL COLLEGE & HOSPITAL, the details thereof are as under:

#### 1. Course in Ethics

- a) All postgraduate students shall complete course in Ethics including Good Clinical Practices and Good Laboratory Practices, whichever is applicable to them, to be conducted by Institutes themselves or by any other method.
- b) The students have to complete the course <u>within one year</u> of the commencement of the batch
- c) No Postgraduate Student shall be permitted to appear in the examination without completing the above course.

# 2. Course in Basic Cardiac Life Support Skills (BCLS)

- a) All postgraduate students shall complete a course in Basic Cardiac Life Support (BCLS) skills and get duly certified.
- b) The students have to complete the course <u>within one year</u> of the commencement of the batch"

3(7) TO CONSIDER THE PROPOSAL FOR CREATION OF CLINICAL PSYCHOLOGY DEPARTMENT IN SANTOSH MEDICAL COLLEGE & HOSPITAL, GHAZIABAD, DELHI NCR.
